PUBLIC NOTICE NOTICE & REGULARITY OF BUDGET COMMISSION MEETINGS

The Budget Commission of Franklin County, Ohio in compliance with RC 121.22(F), hereby establishes the method whereby any person may determine the date, time and place of regular meetings and the date, time, place and purposes of special meetings of the Board, and whereby the news media may be notified of the date, time, place and purposes of special and emergency meetings of the Budget Commission.

1. Regular meetings.

Regular meetings of the Budget Commission will be held the first Monday in February and the first Monday in August as required by RC 5705.27 at 2:30 p.m.in February and 10:00 a.m. in August in the JSB Conference Room, Meeting Room A of the County Courthouse, 369 South High Street, 1st floor, Columbus, Ohio. Additional regular meetings of the Budget Commission will be held the last Monday of each month, unless a legal holiday, then the next business day, at 2:30 p.m. in the JSB Conference Room, Meeting Room A, 1st floor, 369 South High Street, Columbus, Ohio.

The Clerk of the Budget Commission shall give notice of regular meetings by posting a copy of this on the bulletin board in the lobby of the County Courthouse, 373 South High Street, Columbus, Ohio. If the date, time or location of a regular meeting is changed, notice shall be posted as provided in this section at least twenty-four hours prior to the meeting.

2. Special and emergency meetings

Special meetings of the Budget Commission will be held at the call of any member of the Commission. The call for a special meeting shall specify the date, time, location and purposes of the meeting. Unless otherwise provided, special meetings will be held at the office of the County Auditor.

The Clerk shall give notice of the date, time, location and purposes of a special meeting other than an emergency meeting by posting in the same location as provided for posting notice of regular meetings. Notice shall be posted as far in advance of the meeting as practicable, but not less than twenty-four hours prior to the meeting.

If there is sufficient time to provide twenty-four hours' notice, the Clerk shall give notice of an emergency meeting in the same manner as notice of a nonemergency special meeting. Otherwise, notice of an emergency meeting is not required, except as provided in section 3.

3. Notice to news media of special and emergency meetings.

News media who have required notice of special meetings shall be individually notified by the Clerk of the date, time, location and purposes of any such meeting at least twenty-four hours in advance of the meeting. If the meeting is an emergency meeting, the member or members calling it shall immediately notify the media who have requested notification of the date, time, location and purposes of the meeting.

4. Notice of meetings to discuss particular business

The Clerk shall give reasonable advance notice of any special meeting at which a particular type of public business is to be discussed, to any personal who has requested such notice. If time permits, such notice shall be given. A request for notice shall be in writing, shall state the requestor's name, address, telephone number, and the nature of the public business in which the requestor has a particular interest and desires notice. Any such request shall remain in force for 12 months.

5. Special notice required by law

When a particular form or method of notice is required by statute for a public hearing or meeting of the Budget Commission, notice of the hearing or meeting shall be given in the form and manner prescribed by statute, in addition to notice otherwise required under this notice.
